



SCHOOL DRESS CODE PLAN

RATIONALE:

A school's dress code plays an important role in promoting a positive image of the school and creating a sense of identity. There are many reasons to introduce a code of dress for students:

- It allows for easy identification of students during out of school activities
- It provides a platform for students to be "equal" irrespective of family circumstances
- Generally, it is a cheaper option for parents and
- It fosters a sense of 'belonging" and pride in the school.

Caralee Community School has a proud reputation when it comes to the wearing of the school Dress Code, and our School Board acknowledges the importance of having a Dress Code.

SPORTS / FACTION CARNIVAL DRESS CODE:

Sports uniform is only to be worn on Friday and for sporting events (not interschool):

All items can be purchase at the School's P&C Uniform Shop.

Please note:

- **DENIM** – Denim clothing is not permitted to be worn in Western Australian public schools
- **BIKE SHORTS** and **GYM WEAR** - Do not comply with Caralee Community School's Dress Code Plan, however these items in plain black may be worn under school uniform
- **HAIR** – Hair that is longer than the top of the shoulder, is to be tied back at all times whilst at school. This is an Occupational Health and Safety issue
- **MAKE-UP** – No facial make-up should be worn
- **JEWELLERY** – No jewellery should be worn with the exception of watches, plain small sleepers or studs in the ear
- **FOOTWEAR** – It is important to ensure your child has suitable footwear when at school. Tie-up shoes or sneakers are the preferred footwear for school. For safety reasons no thongs, backless slip-ons, beach style sandals or high-heeled shoes are permitted. NO CHILD will be allowed to take part in any out of school activity without suitable footwear
- **HATS** – This school operates a "No Hat, No Play" policy throughout the year. This policy reflects the importance of shading the face/head from the harmful rays of the sun. Consequently, the School Board has endorsed the use of only broad brimmed hats or legionnaire caps.

STUDENT LEADERS:

As representatives of the student body, Student Councillors and Faction Leaders are expected to be positive role models for other students. This includes the Councillors wearing the school uniform and their badges at all times.

EXEMPTIONS:

Any exemptions or objections need to be negotiated by parents directly with the principal.

SANCTIONS:

Parents will be notified when a student fails to wear the school uniform, or where a regular breach of the dress code is apparent. The school has a bank of clean second hand uniforms which are available for loan on a daily basis.

Students who are not in uniform will not be permitted to attend excursions, interschool sports and reward activities.
